

## DOWN

1. Place of service code 02 can be used to indicate this type of service.
2. Software that scans claims for errors.
3. CMS' primary audit programs are TPE, SMRC, and \_\_\_\_\_ Audits.
4. A two-digit alphanumeric code added to a Current Procedural Terminology (CPT®) or HCPCS code that provides additional information.
5. CPT code 93798 is used to report physician or other qualified healthcare professional services for outpatient \_\_\_\_\_ rehabilitation, with continuous ECG monitoring (per session).
